The purpose of this modification is to deobligate excess funds in the amount of \$27,266.82, decreasing the obligated amount from \$1,800,827.47 to \$1,773,560.65. Accordingly, Section B.4 Consideration and Obligation-Fixed Price and Delivery Orders (June 1988) paragraph (m) is deleted entirely and replaced with the following:

"(m) The amount presently obligated with respect to this contract is \$1,773,560.65."
