

The purpose of this modification is to:

- (1) Exercise Option Year One of the order, thereby extending the period of performance of this order through September 5, 2006, and increasing the total estimated (ceiling) amount of the contract by \$3,085,740.28, from \$5,591,914.87 to \$8,677,655.15.

Accordingly, the subject order is hereby modified as follows:

1. Optional Form 347, under Item 17. SCHEDULE, first paragraph, third and fourth sentences are DELETED entirely and substituted with the following in lieu thereof:

"The ordering period for this order shall commence on September 6, 2003 and will expire **September 5, 2006**. The term of this order may be extended at the option of the Government for an additional **two** years."

2. Optional Form 347, under Item 17. SCHEDULE, second paragraph, as modified in Modification No. 10, is DELETED entirely and substituted with the following in lieu thereof:

"The total estimated ceiling amount of this delivery order for the services ordered, delivered and accepted under this order is **\$8,677,655.15**."
