The purpose of this modification is to:

- (1) delete the product class specifications for the (PCNP2), currently an HP 4550n;
- (2) add a new product class for the next generation of Network Color Printer, the HP 4650dn, in the Printers section of CLIN 0004B, CLIN 0005B and CLIN 0006B. This Product Class will become (PCDCP1) and add a Core Service Band to enable support for the new Product Class of Network Color Printer which will be (CSBDCP1). As a result, the changes noted in Attachment 1 to this modification and L-3 Communications Government Services, Inc.'s proposals dated 07/09/2004 with revisions dated, 09/23/2004, 12/17/2004, 03/15/2005, 04/11/2005;
- (3) revise subsection B.8 CONSIDERATION AND OBLIGATION increasing the total estimated cost of the task order by \$7,830.00 from \$42,202,139.82 to \$42,209,969.82. This increase reflects the products and core service bands for a new product class for the next generation of Network Color Printer, the HP 4650dn.

This modification confirms the NRC Contracting Officer's (CO) e-mail message provided to Mr. Brian Magnani, on April 11, 2005, authorization L-3 Communications Government Services, Inc. to provide product class (PCDCP1) for the Printers section and services associated with new product class and core service band (CSBDCP1) for the Printers.

Accordingly, the following section of the task order is hereby modified:

1. The task order is modified to: (a) delete the product class specifications for the (PCNP2), currently an HP 4550n; (b) incorporates, to the Printers section, a new product class (PCDCP1) and core service band (CSBDCP1), as noted in the changes listed in Attachment 1 to this modification.
2. Under Subsection B.8 CONSIDERATION AND OBLIGATION, the first sentence of paragraph (a) is deleted entirely and the following is substituted in-lieu thereof:

“(a) The total estimated amount of this task order (ceiling) for the products/services ordered, delivered, and accepted under this task order is \$42,209,969.82.”
