This investigation was initiated on June 22, 2004, by the U.S. Nuclear Regulatory Commission, Office of Investigations, Region III, to determine if a radiation survey was deliberately deleted from the Radiological Department Tracking System and if a health physics technician was discriminated against for raising radiation protection concerns at the Duane Arnold Energy Center (Allegation RIII-2004-A-0034).

Based upon the evidence developed, this investigation did not substantiate the allegation that a radiation survey was deliberately deleted from the Radiological Department Tracking System, and also did not substantiate the allegation that a health physics technician was discriminated against for raising radiation protection concerns.
