In reference to your phone conversation on 01-26-99 regarding our license amendment the following information was requested :

- **LOCATION:** Southbury Diagnostic Imaging Center(SDIC) is located at Union Square - Building 3 - South Main Street, Southbury CT. 06488.
- **TRANSPORTATION AND ADMINISTRATION OF RADIOISOTOPES:** There will be single unit doses. Doses will be transported in the standard lead box and administered in a lead shield holder. All shipments received from and released to the Radiopharmacy will be wiped and surveyed.
- **SURVEY AREAS:** Daily GM Meter area surveys will be done as part of our normal routine at (SDIC) for restricted and non-restricted areas.
- **HOT LAB DESCRIPTION:** See attachment for drawing of set-up.
- **DOSE CALIBRATOR:** Daily constancy and quarterly linearity checks will be performed.
- **QUARTERLY REVIEW:** Certified Medical Nuclear Physicist to perform exhaustive quality control.
- **PERSONNEL MONITORING:** All Nuclear Medicine Technologists will be required to wear waist as well as finger(ring) badges.

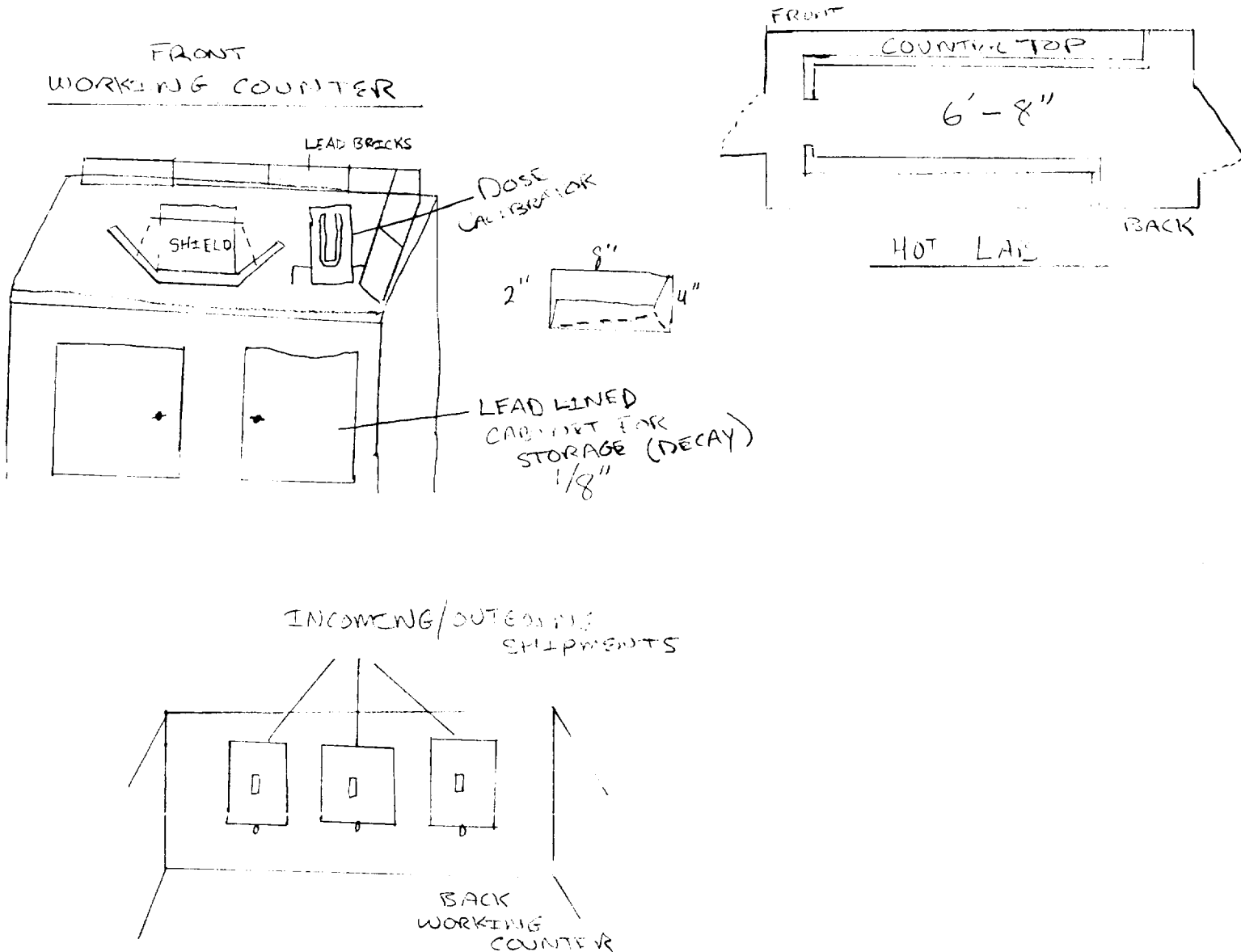
