Dear Administrative Judges:

Pursuant to 10 C.F.R. § 2.336, the Staff hereby provides notice that the LES Hearing File has been updated. The updated pages of the Hearing File Index and Privileged Document List, and an affidavit from the NRC Staff are attached. Please note that the new documents include a draft Safety Evaluation Report (SER). Consistent with Staff practice, the Staff provided a draft version of the SER to LES in order to confirm the factual accuracy of the applicant information reflected in the document and to ensure that proprietary information is not inadvertently released. LES provided the results of its review to the Staff on May 25, 2005. If necessary, the Staff will make any appropriate corrections to the SER before publication as a final document, which is expected to occur by June 15. The Staff will also document its consideration of the potential inaccuracies noted by LES in an internal document which will be made publically available to the extent that it does not contain proprietary information.

The draft SER has been issued in two versions; one which is publically available and one which contains proprietary information. The Staff has withheld from the public version information pertaining to security matters, such as physical protection, which are subject to the provisions of 10 C.F.R. § 2.390(d). The Staff is currently in the process of reassessing whether redacted

documents pertaining to this hearing may be subject to additional public disclosure. The Staff will inform the Board and parties of its determination and any proposed actions to ensure that all documents are properly released to the public as soon as possible.
