This correspondence conveys a request for expedited approval for an additional source for Nuclear Regulatory Commission (NRC) License 08-17447-01.

Americium-241 (AmBe)	Sealed Source, ASA Technology, Product Code AMN13, Model AMN.PE1, U.S. Capsule No. X.2	3 millicuries each and a total of 9 millicuries.

Our Radiation Safety Staff will train and issue a permit to selected officers to handle these items. The permit will include leak testing at 6-month intervals. These sources will be stored and used primarily at a storage site accessible only to CBP personnel. We may need to use these sources at other locations for temporary training but will do so in accordance with the 49 CFR requirements.
