Purpose of Meeting: An open predecisional enforcement conference will be held to discuss the apparent violations identified during a special inspection conducted at the licensee's main office and a temporary job site on April 27, 2005. The apparent violations involve the failure to control or maintain constant surveillance of licensed material that is in an unrestricted area and is not in storage; the failure to ensure that a portable nuclear density gauge or its outer container is locked; and the failure to comply with the applicable requirements of the Department of Transportation regulations, examples of which include failure to properly block and brace a package (transport case) for transport, failure to transport radioactive material with the required information on the labels, and failure to store the shipping paper within the immediate reach of the driver during transport.
