The Broadband Remote Desktop (BRD) system is currently operating under an Interim Approval of the NRC Designated Approving Authority (DAA) until June 30, 2005. The Certification and Accreditation package has been submitted for your approval. We have received your initial comments, however, it is anticipated that the time required for completion of your review and our response to comments will require an extension of the interim accreditation. Prior BRD interim extensions were granted for the following periods:

1. July 28, 2004 to December 31, 2004
2. January 1, 2005 to February 28, 2005
3. March 1, 2005 to April 30, 2005
4. May 1, 2005 to June 30, 2005

I am asking that the Interim Approval to Operate for the BRD pilot be extended until August 31, 2005 so that the comments can be provided and incorporated into the security documentation without interruption to the BRD pilot users.
