### Portsmouth Environmental Bulletin

- November 2004
  - A groundbreaking ceremony on July 28, 2004 signaled the start of construction - on a Uranium Hexafluoride (DUF<sub>6</sub>) Conversion Facility at the Portsmouth Gaseous Diffusion one of two conversion facilities under construction. The second facility is in Paducah, The conversion facilities, an important part of DOE's environmental cleanup program, DOE's inventory of thousands of DUF<sub>6</sub> cylinders to more stable chemical forms suitable for disposal or reuse.
- December 2003
  - Portsmouth Begins Shipments of Scrap Metal to Nevada Test Site - The Waste Disposal Program at the Portsmouth Gaseous Diffusion Plant had two major goals at the beginning of the summer. The first was accomplished on August 7, when six containers of scrap metal loaded onto a trailer and shipped to the Nevada Test Site (NTS) for disposal, marking the first shipment from Portsmouth to NTS.
- May 2003
  - Clean Water Technology at Work - Groundwater treatment is an important aspect of environmental cleanup at the Portsmouth Gaseous Diffusion Plant. Trichloroethene (TCE), the most common contaminant within the shallow groundwater beneath the site.
- October 2002
  - Planting Trees to Clean Up Groundwater - Nearly 700 hybrid poplar trees were planted in the summer of 2002 on the south end of the Department of Energy's (DOE) Portsmouth Gaseous Diffusion Plant as part of a two-year project to implement a remedy to clean up groundwater contamination.
