Pursuant to the requirements of 10 CFR 2.202(a)(2), the Exelon Generation Company, LLC (Exelon) and AmerGen Energy Company, LLC (AmerGen), answer to Reference 1 is being transmitted to the Secretary of the Commission for filing.

In Reference 2, Exelon and AmerGen submitted a request for clarification and extension to respond to Reference 1. The NRC provided a response to Reference 2 in Reference 3. Reference 3 contained the requested clarifications as well as granted our extension request. An extension to respond was granted until 20 days from the date of Reference 3 (i.e., no later then May 2, 2005).

Exelon and AmerGen consent to the Order contained in Reference 1 as clarified in Reference 3.
