Dear Mr. Okoniewski:

My staff has completed the Environmental Assessment (EA) for the amendment of Source Material License No. SMB-920, to allow the recycling of waste water filtercake. The filtercake is to be used as feed material at a cement kiln. The filtercake is produced at the Cabot Supermetals Inc. (CSM) facility in Boyertown, Pennsylvania, which is a subsidiary of Cabot Corporation. The amendment request and application were submitted by letter dated November 24, 2004.

The draft EA for the proposed licensing action was provided to various stakeholders for comment on March 31, 2005. Based on the staff's review of the minor changes to the original application, the EA has been completed and a finding of no significant impact (FONSI) due to continued operation of the facility as proposed, was made. The final EA is enclosed and the FONSI notice will soon be submitted to the Federal Register.
