Reference is made to my letter of November 20, 1969 forwarding our Application for the extension of the expiration date of Provisional Operating License No. DPR-12.

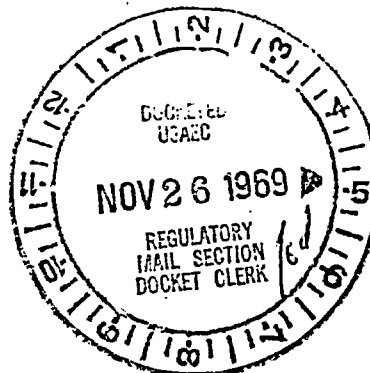
