Dear Mr. Bonfield:

This is in reference to your letter dated March 31, 2005 providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 06-27843-02. In order to continue our review, we need the following additional information:

Your letter of Self-Guarantee followed closely the sample guidance in NuReg-1757 Volume 3 Appendix A format but it excluded statement 8. Statement 8 in Appendix A, pg A-144, reads:

"The guarantor agrees to submit revised financial statements, financial test data, and an auditor's special report and reconciling schedule annually within 90 days of the close of its fiscal year."

The basis of statement 8 may be found in 10 CFR Part 30 App. C.II.B(3), to "repeat passage of the test within 90 days of the close of each succeeding fiscal year."

Please submit an amendment to your Self-Guarantee or a revised Self-Guarantee containing the above statement or similar statement and the same signatures and reviews as on the originally submitted Self-Guarantee.
