Dear Mr. Montgomery,

At present the SABIA radioactive materials license allows the following individuals for R & D at Massey Energy in West Virginia; Mr. Scott Burdett, Mr. Marshall Birchfield, and Mr. Greg Taylor. Since this site is under continuing R & D for a new application, with a configuration presently not covered by the SS&D device registration, these three individuals should remain as authorized users on the SABIA radioactive materials license. When R&D testing is completed, sometime later this year, the SS&D device registry will be amended to include the specifics for this device. At that time, following the completion of the change to the device registration, the device will be transferred to the customer's license and these individuals will be removed from the SABIA license.

Until that time, these three individuals need to remain as authorized users under R&D on the SABIA radioactive materials license.
