Dear Mr. McGiff:

On May 12, 2005, John Nicholson of this office conducted a safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selected examination of representative records. The findings of the inspection were discussed with you, Marlene Larson and Dominic Versage of your organization at the conclusion of the inspection. One finding discussed was Mr. Nicholson's determination that Cornell University performs an annual review of the licensed program but that not every aspect of the program is evaluated annually. Following the discussion of this finding, you agreed to re-evaluate how Cornell University conducts the annual program review in order to assure that all aspects of the program are evaluated annually. This letter replaces the NRC Form 591M that Mr. Nicholson left with you at the conclusion of the inspection.

Within the scope of this inspection, no violations were identified.
