Dear Dr. Tsang:

This is in reference to your letter dated May 19, 2005 requesting to amend Nuclear Regulatory Commission License No. 29-30003-01. In order to continue our review, we need the following additional information:

- 1. Your letter should have been signed by a management representative rather than the nuclear medicine technologist. Please submit a letter signed by a management representative indicating that management has reviewed the letter and concurs in the statements and representations contained therein. Note also that a management representative should sign all future correspondence that requests a change in your license. Alternatively, a management representative can submit written authorization empowering the nuclear medicine technologist as Radiation Safety Officer to sign documents allowing for changes in the license.
- 2. In your letter, you request that Murat Karatepe, M.D. be listed on your license as an authorized user. Please indicate the authorizations for which Dr. Karatepe is to be listed. Your license currently has authorizations for nuclear medicine studies conducted under 10 CFR 35.100 and 35.200.
