As requested by your letter of February 15, 2005, the following revised financial assurance for decommissioning is provided in accordance with Title 10, Code of Federal Regulations, Part 30.35 (10 CFR 30.35) for NRC License Number 29-01022-06 issued to this Command. This revised financial assurance for decommissioning is an amendment to our 26 August 1993 memorandum.

In accordance with 10 CFR 30.35, this is to certify that (as a federal licensee) decommissioning funding will be obtained when necessary for the termination of the aforementioned NRC license. Dollar amounts for future decommissioning costs, though difficult to predict, are currently revised in the \$1,125,000.00 range (from \$750,000.00) using 10 CFR 30.35 criteria.
