

The purpose of this modification is to deobligate FY'04 funds in the amount of \$76,089.97, thereby decreasing the obligated amount of the subject contract from \$1,537,584.00 to \$1,461,494.03.

Accordingly, the contract is hereby modified as follows:

1. Under Subsection B.18, Consideration and Obligation-Work Orders, the first sentence of Paragraph (b) is deleted in its entirety and substituted with the following in lieu thereof:

"(b) The amount presently obligated by the Government with respect to this contract is \$1,461,494.03."
