

The purpose of this modification is to 1) Increase the amount funded in the contract for CLINs 1 through 5 by \$186,180.00 from \$514,371.00 to \$700,551.00; 2) Increase the amount funded in the contract for CLINs 8 and 9 by \$27,820.00, from \$70,760.00 to \$98,580.00, and 3) Change the Key Personnel designated in the contract. Accordingly, the subject contract is hereby modified:

1. Section B.5 Consideration and Obligation –Mixed Contract Types, paragraphs (c) and (d) are deleted and substituted with the following in lieu thereof:

“(c) The amount currently obligated by the Government with respect to CLINs 1 thru 5 is \$700,551.00, of which the sum of \$651,512.00 represents the reimbursable costs and \$49,039.00 represents the fixed fee.”

(d) It is estimated that the amount currently allotted will cover performance through November 30, 2005.”

2. Section B.5 Consideration and Obligation –Mixed Contract Types, paragraph (h), is deleted and substituted with the following in lieu thereof:

“(h) The amount currently obligated by the Government for CLINs 8 and 9, ergonomics and occupational safety and health is \$98,580.00.”

3. Section H.4, Key Personnel, paragraph (a), is deleted and substituted with the following in lieu thereof:

“Vincent Pasqual, Fitness Center Director  
Ellen Stephanie Robinson, Associate Fitness Director  
Rita Hendershot, Lead Nurse”
