

#### 14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to: (1) exercise Option Year 2 of this contract and increase the ceiling by the amount of Option Year 2; (2) change the acceptance date of this contract from 7/31/2003 to 7/29/2003. Accordingly, Option Year 2 of this contract is hereby exercised, extending the contract period to July 28, 2006. In addition, the contract price is fully funded by \$3,744.84 from \$25,331.40 to \$29,076.24; and the acceptance date of this contract is changed from 7/31/2003 to 7/29/2003.

All other terms and conditions remain unchanged.
