This modification confirms the verbal agreements between the U.S. Nuclear Regulatory Commission (NRC) and the Bethesda North Marriott Hotel and Conference Center (Marriott) in which it was agreed that the date in which NRC confirms its reservation with the Marriott is extended from 3/18/05 to 4/6/05, as well as the extension to the period of performance from 3/18/05 to 4/6/05.

In accordance with Section C.5, the NRC, hereby confirms its reservation with the Bethesda North Marriott Hotel and Conference Center for RICs 2006 and 2007. Therefore, the purpose of this modification is to exercise the Option Period under the contract, subject to the availability of funds, pursuant to Section C.3, FAR Clause 52.232-18, Availability of Funds. As a result, the period of performance is extended to March 23, 2007. Accordingly, the contract is modified as follows:

1. **Section B.3.1, Consideration and Obligation** is deleted entirely and replaced with the following:

"(a) The total estimated price of this contract for the products/services ordered, delivered, and accepted under this contract is \$735,820.20.

(b) The amount presently obligated with respect to this contract is \$242,123.40."

2. **Attachment 2, Statement of Work (SOW)** is deleted entirely and replaced with the attached SOW because of the following deletions:

Under **Section C, Scope of Work, Item Number (19)** is hereby deleted. (See Page 3 of 6 in which Item Number (19) stated: "The conference facility shall provide no cost parking for attendees."

Under **Section C, Scope of Work**, the **first paragraph** under **Item Number (20)** is hereby deleted and the Item Number is renumbered "(19)." (See Page 3 of 6 in which the first paragraph stated: "The conference facility shall set aside a "block" of 200 sleeping rooms for three nights, with 25 rooms being offered at the Government per diem rate. This block of rooms shall be available until two (2) weeks prior to the RIC meeting start date."

Section I, Period of Performance/Option for One Two-Year Period, found on Page 6 of 6, is deleted entirely and replaced with the following:

"The period of performance is March 4, 2005, through March 23, 2007. There are no option periods remaining under this contract."

As a result of this modification, the contract ceiling amount is increased to \$735,820.20. All other terms and conditions remain the same.

A summary of obligations for this contract, from the award date through the date of this action, is given below:

Total FY05 obligation amount: \$242,123.40

Total NRC obligations: \$242,123.40

This modification obligates FY05 funds in the amount of \$2,850.00.
