

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to allot \$140,000 in funding to the contract to support the completion of software modification nos. 13 and 28 (nos. per contractor proposal) from contract modification no. 45 and to fund two months of June and July 2005 for an audiovisual service plan for the recently installed conference display system (mod 44). The contract is hereby modified as shown on the attached page.

1. \$140,000 is provided for completion of software modifications nos. 13 and 28 as numbered in the contractor proposal for contract modification no. 45. This funding also supports the audio-visual services plan for equipment installed under contract modification no.44. As a result, Section B.4 of the contract is hereby replaced with the following revised Section B.4:

B.4 CONSIDERATION AND OBLIGATION

(a) The total estimated cost to the Government for full performance of this contract is \$6,240,770.41 of which \$5,867,702.94 represents the reimbursable costs and of which \$373,067.47 represents the fixed fee.

(b) The amount currently obligated with respect to this contract is \$5,634,706.40 of which the sum of \$5,297,869 represents funds for the reimbursable costs and \$336,837.40 represents funds for the fixed fee.

2. All other terms and conditions remain unchanged.
