This is to follow up to the voicemail message I left for you this morning regarding the amendment request dated April 14, 2005 to add Joseph Oldakowski, MS, DABR, as an Authorized Medical Physicist (AMP) for use of your high dose rate remote afterloader (HDR) unit.

I spoke with Rich Tenpenny, referred him to the requirements of 10 CFR 34.961(c) and told him that we still need the following:

- a) Documentation of receipt of the Rutgers master's degree and listing of the major field (transcript submitted did not show these)
- b) Further documentation to support one year of fulltime training in therapeutic radiological physics. So far you have documented the following coursework:

- 40 hour Nucletron Treatment Planning Course (2004)
- 80 hour Dosimetry Course (1993)
- 80 hour External Beam Calibration Course (1992)
- 3 Credit hour course in Radiotherapy (1985)

Please provide additional coursework or, alternatively, a detailed description of training provided by Rich Tenpenny, such as textbooks used and topics discussed. Demonstrate that this training totals to the equivalent of one full-time year.

- c) Further description of the additional year of fulltime work experience supervised by Rich Tenpenny. Your letter dated documents approximately 526 hours. This work experience is not limited to NRC-licensed activities; it may also include other therapeutic radiological physics areas, such as activities related to linear accelerator treatments.

As noted in my first e-mail to you, it may be necessary to submit this application to NRC headquarters for further evaluation.

Please respond within 2 weeks. You may fax your response to 610-337-5269, referencing mail control 136893. Please leave an e-mail or voicemail message to alert me when the fax is sent.
