3. Summary of the report:

On 3/11/2005, Grand Gulf Nuclear Station (GGNS) shipped a Type B cask containing irradiated hardware. One out of six reinforcing blocks that are part of the shipping cask impact limiter structure per Drawing No. 0999-D-07, Revision 8, referenced in the Certificate of Compliance, was not in place during the shipment. No personnel received additional radiation exposure as a result of this event.

4. Corrective actions taken by the licensee:

The shipment was stopped and the cask was returned to GGNS. As assessment was conducted and concluded that the omission of one out of six of the load distributor blocks in the cask assembly reduces the margin of safety very slightly and the package requirements of 10 CFR Part 71 were still met.

GGNS conducted a Human Performance stand-down to reinforce standards for self-checking and peer checking. Duratek, the Certificate Holder, revised the cask procedure to include independent verification of steps that are vital to meeting the Certificate of Compliance requirements.
