

Please be advised that on or about May 27, 2004, a nuclear density gauge provided pursuant to our contract for the captioned project was delivered to your attention by Humboldt Scientific Inc. as directed. This gauge has been utilized, stored, maintained and operated by NJDOT Personnel for the past year at the job site in Franklin Township (Malaga).


Pursuant to our USNRC License, this purchase and delivery of the device to your office and personnel constitutes a transfer. As such, we require the NJDOT provide the following information for our records and to satisfy the requirements of the USNRC pursuant to Part 30, Rules of General Applicability to Domestic Licensing of Byproduct Material.

1. Copy of the valid USNRC license for the Model HS-5001 device provided.
2. Receipt issued by NJDOT certifying receipt of the device and accepting same subject to compliance with applicable USNRC requirements.
3. Copy of shipping documents for said device including a notation of the serial number of the device.

As this transfer occurred over one year ago, Midlantic Construction LLC requests that the NJDOT immediately comply with this request and provide the above documentation within ten (10) business days or by June 24, 2005.
