Dear Licensing Assistance Team:

An application for renewal of the subject license is submitted for your approval. Please refer to the attached NRC Form 313 for Items 1-4. The nature of the renewal is described below:

Item 5: No licensed materials as detailed in Item 6 of the current license are currently maintained. All licensed materials were removed from Crowell Hall and Crowell Hall Annex during final Decontamination and Decommissioning as detailed in previous communications and amendments. Crowell Hall was subsequently demolished. All licensed materials used within the new Biology Building (Phosphorus 32 and Phosphorus 33) were decayed in storage in accordance with Number 15 of the license conditions. All Phosphorus 32 and Phosphorus 33 was held for 10 half lives, surveyed, found to be non-radioactive, and disposed of in the regular trash.

Item 6: The College requests to renew its license as a storage only (pending restart) license.

Item 7: Kathryn Leverton shall remain as the Radiation Safety Officer. Ms. Leverton's training and experience have been previously submitted.

Should the status of The College's Radiation Program change, an amendment to the license will be issued in accordance with NUREG 1556, Vol. 7 for NRC approval prior to restart of licensed activities.
