I am responding to your letter dated April 29, 2005, which forwarded your annual update of the surety amount for the UNC Church Rock Source Materials License SUA-1475 for U.S. Nuclear Regulatory Commission (NRC) staff review and approval. We have completed the initial processing of your submittal, which is an administrative review.

We have determined that the information provided in the document is sufficient to begin the technical review of the revised surety. Please note that the technical review may identify omissions in the submitted information or technical issues not identified during the administrative review that require additional information. We will inform you separately of our schedule for completing the technical review.

In addition, your letter withdrew the amendment request, submitted by letter dated January 10, 2005, to change the reporting date for the annual financial surety. In response to your withdrawal, that licensing action has been closed.
