This is to inform you of a change in the corporate status of Forbes Regional Hospital. Effective July 1, 2005, Forbes Regional Hospital, Monroeville, PA, will merge with The Western Pennsylvania Hospital, Pittsburgh, PA. The name of Forbes Regional Hospital will be changed to The Western Pennsylvania Hospital – Forbes Regional Campus and we are requesting our license to be amended to reflect this change. Both hospitals are currently members of The West Penn Allegheny Health System and will remain so. The merger will result primarily in the unification of hospital administration, boards of trustees, financial services, and the medical staffs. There will be new shared clinical programs as well. The staff members of the Radiology/Nuclear Medicine departments of each hospital will not change. The reporting official here at Forbes, however, will. M. Joseph Grennan, Jr., M.D., Vice President, Clinical Quality and Resource Management, will now be the administrative individual in charge of the Imaging Department at Forbes and the contact person for the DEP/NRC, replacing Darlette Tice.
