On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to your letter of June 3, 2005, in which you provided comments on the 10 CFR 20.2002 process for off-site disposals. You requested that NRC staff consider the comments you provided in order to make the process more consistent and to provide opportunities for public participation. Many of the comments raised in your letter are currently undergoing review based on the Commission's recent direction in Staff Requirements Memorandum (SRM) dated June 30, 2005. This SRM responds to Commissioner Jaczko's Memorandum dated May 18, 2005, on improving the transparency in the 10 CFR 20.2002 process. The Commission has requested that the staff provide recommendations by December 28, 2005, on the options to enhance public understanding and awareness of the 10 CFR 20.2002 approval process.

In addition, the staff is currently updating and developing guidance documents related to 10 CFR 20.2002 processes. A draft revision to NUREG-1757, *Consolidated NMSS Decommissioning Guidance*, will contain updated information for on-site disposals. The public will have an opportunity to provide comments to this draft beginning in the October 2005 timeframe. Guidance is also being consolidated and developed for 10 CFR 20.2002 off-site disposals.

The staff appreciates your timely recommendations on the various 10 CFR 20.2002 process for alternate disposal procedures and will consider them as it responds to the Commission and updates relevant guidance.
