BROWNS FERRY NUCLEAR PLANT (BFN) - UNITS 1, 2, AND 3 - INDEPENDENT SPENT FUEL STORAGE INSTALLATION (ISFSI) - WITHDRAWAL OF REQUEST FOR NRC ACCEPTANCE AT BFN TO NOT REPERFORM CERTAIN PRE-OPERATIONAL TESTING AND TRAINING EXERCISE REQUIREMENTS PREVIOUSLY PERFORMED AT SEQUOYAH (SQN) NUCLEAR PLANT

By letter dated June 15, 2005 (Reference 1), TVA requested that the Nuclear Regulatory Commission (NRC) accept the performance demonstration of certain Pre-operational Testing and Training Exercise elements for the BFN ISFSI previously performed at TVA's Sequoyah Nuclear (SQN) plant. With this letter, TVA is withdrawing that request.

TVA is using the Holtec International, Inc., HI-STORM 100 Cask System for both the BFN and SQN sites. Certificate of Compliance (COC) No. 1014, Amendment No. 1 specifies certain conditions that must be met prior to first use of the system. In Reference 1, TVA requested that the NRC accept activities previously performed at its SQN plant to demonstrate capabilities specified in Sections 10.f and 10.j of the COC. However, based on subsequent discussions with the NRC Staff, TVA has agreed to withdraw its request.
