14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
- A. The purpose of this modification is to increase the task order ceiling, and provide fund for this increase, as a result of the Cooper SSDPC inspection requiring more effort than originally anticipated.
- B. The estimated cost of the task order is increased by \$3,184.60 from \$28,042.29 to \$31,226.89.
The fixed fee is increased by \$127.38 from \$899.03 to \$1,026.41.
The total cost and fixed fee is increased by \$3,311.98 from \$28,941.32 to \$32,253.30.
- C. All other terms and conditions of the task order remain the same.
