

Accordingly, the following change is hereby made:

Under Paragraph B.4 -CONSIDERATION AND OBLIGATION-DELIVERY ORDERS, the first sentence of Subparagraph B4(b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"(b) The amount presently obligated with respect to this contract is \$17,048,187.08."
