The purpose of this modification is to: (1) decrease the contract ceiling and obligated amounts by \$711.46 from \$3,275,347.00 to \$3,274.635.54, in accordance with the Contractor's Release dated July 3, 2005, and (2) incorporate the final negotiated indirect cost rates under Subsection G.2 of the contract for the period covering May 15, 1998, through July 31, 2003.

Accordingly, the contract is hereby modified as follows:

- (1) Under Subsection B.3 <u>CONSIDERATION_AND OBLIGATION COST PLUS FIXED-FEE</u>, Paragraphs a and c are deleted in their entirety and substituted with the following in lieu thereof:
 - "(a) The total estimated cost to the Government for full performance of this contract is \$3,274,635.54, of which the amount of 3,089,237.97 represents the estimated reimbursable costs, and the amount of \$185,397.57 represents the fixed fee.
 - (c) The amount currently obligated by the Government with respect to this contract is \$3,274,635.54, of which the amount of 3,089,237.97 represents the estimated reimbursable costs, and the amount of \$185,397.57 represents the fixed fee."
- (2) Under Section G <u>Contract Administration Data</u>, Subsection G.2, Indirect Cost Rates is deleted in its entirety and substituted with the following in lieu thereof:
