NRC License No. XCOM1133 authorizes export of nuclear reactor components to various countries listed in 10CFR110.26(a) for retention or return to the U.S. The total value of equipment to be exported is \$6,000,000. To date, we have exported \$5,055,090 value of equipment under this license.

We request the following: 1) increase the total value of equipment to be exported from \$6,000,000 to \$12,000,000; 2) extend the expiration date from December 31, 2005 to December 31, 2008; and 3) change the attention line of the licensee from M.J. LaRue to Elaine Ferko.

Attached is NRC Form 629 Authorization for Payment by Credit Card in the amount of \$230 payable to the U.S. Nuclear Regulatory Commission for the processing of this request for an amendment to the export license as required by law.
