3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on Oct 24, 2004. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of CANMAR Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about November 1, 2004. The containers will then be loaded onto the rail for importation to Sarnia, ON/Port Huron, MI. The containers will enter the USA at Detroit, MI on or about November 12, 2004, and will continue on rail to Chicago, IL. The inland transportation from Montreal, PQ to Metropolis, IL will be the responsibility of RSB Logistic Services Inc.
