You stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- 1. The information contained in the subject document is confidential commercial information under 2.390(a)(4).

- 3. The public disclosure of the information contained in the document would harm the competitive position of Westinghouse since this report contains substantial sensitive information related to the company's nuclear criticality safety program.
