When I came back from the meeting with Reliance Energy, Oscar was actually in the CEO's office. So, I took him from the CEO's office, and we went off to a quiet room here at Sargent & Lundy.

SPECIAL AGENT LANGAN: Okay, and what did you guys discuss when you met?

[REDACTED]

He discussed his whole employment situation.

SPECIAL AGENT LANGAN: With Exelon?

[REDACTED]

With Exelon, yes.

Well, in general, he told me that he felt that Exelon finally got him. That he sent an E-mail of some sort to various Exelon executives, he specifically mentioned Corbin McNeil, John Rowe, Oliver Kingsley. And that shortly thereafter he was asked to leave by security. And was told that he could come back over the weekend, and do any kind of final packing.

But, he was subsequently escorted from the building, and asked to leave. And that's the way he described it, and that's how I found out that he was no longer physically working at the First National

4 [REDACTED] He said that it was something
5 to the effect, well, you guys finally did it, you
6 finally got me.

11 believe it was some kind of financial auditing

17 and wrote some kind of introduction saying, you know,
18 like, hey, you finally got me, this all worked out the
19 way you had it planned, to those executives, and some
20 others. I got the idea it was a broader distribution.
21 And that was the nature of it.






