Information Needed For Transfer of Control

The transaction is a transfer of the assets of Danville Regional Medical Center (the "Hospital") by Danville Regional Medical Center, a Virginia non-stock company ("Transferor"), including but not limited to the licensed materials. The name of the Hospital did not change. This transaction was completed on July 1, 2005.
