Please note that I was unable to approve your request to delete your intravascular brachytherapy authorizations at this time because the information submitted was insufficient to complete my review. Please submit the following additional information, addressed to my attention, and reference control number 314389, to facilitate proper handling:

Please provide copies of the most recent leak tests for each of the last sealed sources you possessed for each intravascular brachytherapy system, the Cordis and the Guidant Galileo.

Please also submit the name, telephone and fax number of the appropriate contact person to whom we can address questions about your licensing correspondence.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
