This confirms verbal authorization provided on May 31, 2005, for change from basic to advanced level for clerical work for ADM.

This also confirms verbal authorization provided on June 10, 2005, for additional funds of \$5,000 for extension to Delivery Order #12 through 7/8/05 for RES.

The purpose of this modification is to obligate funds in the amount of \$1,285.71 for ADM, \$171 for OIP (Delivery Order #15), and \$5,000 for RES (Delivery Order #12). Accordingly, the contract is hereby modified as follows:
