This is a follow up to my telephone conversation with Mr. Tennant this afternoon, Friday July 22, 2005, regarding your request to amend NRC license STA-1455 and the additional information you provided at my request in your letter dated July 21, 2005 that was faxed to me. To continue my review of your request I need additional information.

Your letter dated July 21 stated the SSD registration for the Am-241 source you are planning to purchase is MA-1059-S-278-S. This SSD registration has two AEA Technology-QSA Inc. model number Am-241 sources associated with it. Model AMC.36 has a maximum activity amount of 140 millicuries and Model AMC.L1 has a maximum activity of 203 millicuries. Please clarify if you want both sources or one or the other source listed on your license.
