2) Physical Description

This shipment consists of 24 x 48Y Cylinders loaded on one lash barge. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U is 196,800 kgs. The net weight of U-235 is 1,392 kgs.


