SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
(AW-05-2020) (TAC NO. MC3065)

Dear Mr. Gresham:

By letter dated June 29, 2005, Westinghouse Electric Company submitted an affidavit dated June 29, 2005, executed by J.W. Fasnacht, Customer 1st Leader, Nuclear Services, requesting that information in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390:

Responses to NRC's Draft Safety Evaluation By the Office of Nuclear Reactor
Regulation Topical Report WCAP-16260-P, "The Spatially Corrected Inverse
Count Rate (SCICR) Method for Subcritical Reactivity Measurement"

A nonproprietary copy of the document was provided for placement in the Nuclear Regulatory Commission's (NRC's) Public Document Room and for addition to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (i) The information sought to be withheld from public disclosure is owned and has been held in confidence by Westinghouse.
- (ii) The information is of a type customarily held in confidence by Westinghouse and not customarily disclosed to the public.
 - (a) The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies.
 - (c) Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the information in the document entitled, "Responses to NRC's Draft Safety Evaluation By the Office of Nuclear Reactor Regulation Topical Report WCAP-16260-P, 'The Spatially Corrected Inverse Count Rate (SCICR) Method for Subcritical Reactivity Measurement'," marked as proprietary, will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
