CONDITIONS

- 10. Licensed material may be used only at the licensee's facility located at 3114 Point Township Drive, Northumberland, Pennsylvania except that contaminated items may be picked up, received and possessed in licensee's transportation vehicles.
- 11. A. Licensed material shall be used by, or under the supervision of, Mark Fellows.
 - B. The Radiation Safety Officer for this license is Mark Fellows.
- 12. Special nuclear material may not be possessed in quantities exceeding 350 grams of contained U-235, 200 grams of U-233, 20 grams of plutonium, or in any combination of them in accordance with the following formula: For each kind of special nuclear material possessed, determine the ratio between the quantity possessed and the quantity specified above for the same kind of special nuclear material. The sum of such ratios for all kinds of special nuclear material in combination shall not exceed unity.
- 13. The licensee may not receive licensed material until the licensee meets all financial assurance requirements for decommissioning in accordance with 10 CFR 30.35, 40.36, and 70.25 and the U.S. Nuclear Regulatory Commission has approved such financial assurance.
- 14. This license does not authorize the packaging nor possession of radioactive waste except that generated as a result of the laundering activities performed in the licensee's permanent laundry facility located at 3114 Point Township Drive, Northumberland, Pennsylvania.
- 15. This license does not authorize the laundering of contaminated items at temporary job sites of the licensee nor at customer facilities except as specifically authorized pursuant to the terms and conditions of specific licenses issued to customers of the licensee by the U.S. Nuclear Regulatory Commission or an Agreement State.
- 16. The licensee is authorized to transport licensed material in accordance with the provisions of 10 CFR Part 71, "Packaging and Transportation of Radioactive Material."
