Finally, Mr. Hawes or his counsel shall also timely indicate whether he wishes to request an extension of today's deadline for any reply to the Staff's Response to his request for hearing.

After we receive the preceding information, we will notify all parties of a new date for the conference call, bearing in mind the scheduling conflict Staff counsel has brought to our attention.
