This is in response to your letter dated June 13, 2005, on behalf of Mr. Jalal Hamshari, President of Star Lite Global, Inc., regarding his request for a refund in the amount of \$2,700 for a license application dated June 5, 2003, that was submitted to NRC's Office of Nuclear Materials Safety and Safeguards (NMSS), to sell krypton bulbs. I regret to inform you that I am denying Mr. Hamshari's request for a refund as the fee is non-refundable.

In accordance with 10 CFR 170.12(a) (copy enclosed for your reference), "the application or registration(s) fee is charged whether the Commission approves the application or not. The application or registration fee(s) is also charged if the applicant withdraws the application or registration." The withdrawal of Mr. Hamshari's request is without prejudice and he may submit another request within one year from the date of this letter by referring to mail control number 022324. At that juncture, he would not be charged an additional application fee since the request would be considered as a continuation of the aforementioned mail control number.

In addition, the NRC does not have a record of receiving a payment in the amount of \$2,700 from Mr. Hamshari. The NRC received two checks from Mr. Hamshari. The first check (number 7340) dated June 9, 2003, in the amount of \$2,300, and the second check (number 7461) dated July 16, 2003, was in the amount of \$100 (copies of checks are enclosed for your information).
