## SUBJECT: ADVANCED CARE MEDICAL, INC., REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION FOR AMENDMENT TO LICENSE, CONTROL NO. 137046

Dear Mr. Lamoureux:

This is in reference to your letter dated July 8, 2005 requesting to amend Nuclear Regulatory Commission License No. 06-30764-02MD. In order to continue our review, we need the following additional information:

1. You are requesting the referenced distribution license be amended to state under item 1, "Advanced Care Medical, d/b/a BrachySciences and World Wide Medical Technologies". You have stated, in your letter dated July 8, 2005, that these are all separate legal entities. Please explain your rationale for requesting BrachySciences and World Wide Medical Technologies be listed as "dba" on the Advanced Care Medical distribution license. Also, please explain as separate legal entities why they should not have to apply for separate licenses to both possess and distribute licensed material.
