SUBJECT: TERMINATION OF YOUR NRC RADIOACTIVE MATERIALS LICENSE

On June 2, 2005, you contacted the U.S. Nuclear Regulatory Commission and indicated that you wished to terminate your NRC radioactive materials license. The NRC staff has reviewed your sealed source leak test results. Based on its review, the staff has concluded that: 1) all licensable radioactive material has been removed from your facility, and 2) residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions no further remediation or actions with respect to NRC regulated material is required. Your facility is suitable for unrestricted use and U.S. Nuclear Regulatory Commission license number 02-21080-01 for your facility at Tuba City, Arizona 86045, is hereby terminated.

BASIS FOR TERMINATION AND/OR RETIREMENT: Licensee requested license termination by submitting NRC Form 314 and letter dated June 2, 2005. Licensee possessed four Troxler portable nuclear gauges model 3400 series and one Campbell Pacific Nuclear portable gauge model MC-1. All five portable gauges were transferred from the Department of Interior, Bureau of Indian Affairs, to a licensed entity (CPN International, Inc., Martinez, California, license number 1100-07). Records of leak tests are negative.

**TERMINATION DOCUMENTATION**

1. License termination meets Type I criteria: YES
- YES      Licensee used sealed sources only and the most recent leak test demonstrates that they did not leak while in the licensee's possession.

Department of the Interior, Bureau of Indian Affairs, was determined to meet the criteria of Group I. Licensees decommissioning under Group I would not be required to develop a decommissioning plan.

2. Termination survey required: NO

3. Form 314 or equivalent submitted: YES

Staff verified disposition of sealed sources by 1) receipt of Form 314 from licensee stating that portable gauges were transferred to a licensed entity, and 2) letters from CPN International acknowledging receipt of all 5 gauges.

4. Licensee transfer records discussed in 10 CFR Parts 30.35, 30.36, 30.51; 40.36, 40.42, 40.61; or 70.25, 70.38, 70.51 NO

5. NRC closeout inspection required: NO

6. Confirmatory or Side-by-Side Survey YES

Leak Test Results were submitted by the licensee. Results were negative.

Because the gauges did not leak while stored in the authorized facility, a survey was not required. Verification of the leak test results was sufficient.
