## MEMORANDUM AND ORDER

(Memorializing Results of Prehearing Conference)

On August 10, 2005, the Licensing Board conducted a telephone prehearing conference with the parties, including representatives of applicant Louisiana Energy Services, L.P., (LES) the NRC staff, and intervenors Attorney General of New Mexico (AGNM), New Mexico Environment Department (NMED), and the Nuclear Information and Resource Service and Public Citizen (NIRS/PC). During the conference, the Board and the parties discussed scheduling for the upcoming evidentiary hearing on contested issues and the mandatory hearing on uncontested matters. As reflected in the transcript of that conference, see Tr. at 1693-1737, the Board addressed those matters as follows:

#### A. Mandatory Hearing Schedule

In accord with the process suggested by LES and the staff in a July 2004 joint report on hearing procedures, the Board establishes the following schedule for the conduct of the mandatory hearing:
